**1) Regulations and Annex**

I declare that I have read, understood, and accepted the ITS Regulations and the official event annex (UM 2026 Annex), available through the organization's official channels, and I undertake to comply with them in full.

**2) Physical fitness and health**

I declare that I am physically and psychologically fit to participate; that I have undergone (or, at my own responsibility, will assume not having undergone) recent medical check-ups; and that I do not suffer from any illness, condition, or injury that could be aggravated by my participation. If I experience symptoms or an injury before or during the event, I will immediately inform the organization or medical staff and will accept their decision regarding my continuation.

**3) Knowledge of the event**

I declare that I have previously reviewed the distance, route/course, lap-based format, schedules, and event recommendations, and that I understand the nature of trail running in a natural environment.

**4) Assumption of risk (additional risk due to the natural environment)**

I acknowledge that this competition takes place in a natural environment with limited access/control points, involving risks inherent to the sport and terrain, including, but not limited to: falls, sprains, fractures, impacts, cuts, hypothermia, sunstroke/heat illness, dehydration, allergic reactions, asthma attacks, extreme fatigue, changing weather conditions, contact with animals or objects, and other foreseeable or unforeseeable risks.

I participate voluntarily and fully assume all risks and consequences, to myself and to third parties, arising from my participation.

**5) Minimum safety gear (mandatory)**

I undertake to carry and correctly use the minimum gear required by the organization for my distance:

- Bottles or hydration equipment (sufficient capacity)
- Change of clothing
- Rain layer/jacket

I declare that my equipment is in good condition and that I know how to use it properly.

**6) Conduct and safety**

I undertake to:

- Travel only on the marked route, without taking shortcuts or creating new paths.
- Follow the instructions of staff, judges, medical personnel, and organizers.
- Not obstruct passage, not assault anyone, and not endanger others.
- Respect the lap-based format and the official lap counting/control.

**7) Medical care and authorization of assistance**

I authorize the event's medical personnel to provide first aid, treatment, or any necessary measures, and I accept that they may instruct me to withdraw from the race if they deem it necessary for my health and/or safety.

**8) Environmental care (“what goes in, comes out”)**



I undertake to strictly respect the environment, especially:

- a) Not to harm flora or fauna.
- b) Not to litter; to use designated disposal points and/or carry my waste with me.
- c) To respect local regulations and the organization's instructions.

## 9) Image, recording, and usage rights

I authorize the organization and the Ultra Machu Picchu by ITS brand (Corp. Tupac E.I.R.L.) to use my image (photographs, audio, and video) captured during the event for promotional, informational, and/or commercial purposes, without financial compensation, in any media and for an indefinite period.

## 10) Personal data and chip timing

I authorize the processing of my personal data for sporting and operational purposes of the event (registration, operational insurance, results, rankings, essential communication).

The organization may share only essential data with the chip-timing provider and related services, strictly for identification and publication of results.

## 11) Release of liability

By participating voluntarily and under my sole responsibility, I hold harmless and release from any civil, criminal, administrative, or any other liability for damages, injuries, temporary or permanent disability, death, theft or loss of property, and/or damages to third parties:

- collaborators, volunteers, sponsors, suppliers,
- authorities and/or owners/title holders of public or private premises where the event takes place,
